# EXPRESSION OF INTEREST (EOI) FOR PROVISION OF TRANSPORTATION SERVICES AT ABEPL

#### INTRODUCTION:

Assam Bio Ethanol Pvt. Ltd. (ABEPL) is India's first commercial bamboo-based 2G bio-refinery, located in Numaligarh, Assam. Established as a joint venture between Numaligarh Refinery Limited (NRL) (a Government of India PSU) and Finnish partners Chempolis Oy and Fortum. ABEPL is designed to process approximately 500,000 metric tons of green bamboo per annum, producing around 49,000 tons of fuel-grade ethanol along with furfural, acetic acid, bio-coal, and captive green energy.

To ensure a steady feedstock supply, ABEPL has developed a sustainable supply chain spanning across Central and Upper Assam and adjoining districts of Arunachal Pradesh, Nagaland, and Meghalaya. This model engages bamboo farmers, harvesters, Local Level Entrepreneurs (LLEs) i.e., decentralized bamboo chipping units, and transporters — strengthening rural livelihoods and boosting the regional economy.

# **OBJECTIVES:**

The objective of this EOI is to identify and engage competent agencies for the transportation of bamboo chips from ABEPL's designated LLEs within Assam and adjoining states to ABEPL plant at Numaligarh, Assam. The agencies will be responsible for ensuring the timely, safe, and efficient movement of materials to support a continuous supply chain. The transportation network is expected to be cost-effective, reliable, and sustainable, while minimizing transit losses and maintaining quality. Through this initiative, ABEPL also aims to encourage the participation of transporters and service providers.

#### **BRIEF SCOPE OF WORK:**

The scope of work involves the transportation of bamboo chips from designated LLEs across Assam and adjoining states to ABEPL plant at Numaligarh.

#### Material to be transported:

o **Bamboo Chips** – approx. 3,75,000 MT per annum.

#### Logistics requirements:

- Bamboo Chips: 7-45 mm, bulk density 300–350 kg/m³, moisture content 20–30%, transportable by Heavy Commercial Vehicle (HCV) over one-way distances of 40–300 km.
- Regions of operation which include districts of:
- Assam: Charaideo, Dhemaji, Dibrugarh, Golaghat, Jorhat, Kamrup Metro, Karbi Anglong, Morigaon, Nagaon, North Lakhimpur, Sivasagar, Sonitpur, Tinsukia, Udalguri, and West Karbi Anglong.

Nagaland: Wokha, Mokokchung.

Arunachal Pradesh: Papumpare, East Siang, Lower Dibang Valley.

Meghalaya: Ri Bhoi.

# Operational requirements:

- Trucks upto 10 wheeler, suitable for transporting bamboo chips with maximum carrying capacity.
- Timely placement of trucks on contracted routes as per transportation plan issued by ABEPL.
- o Centralized fleet movement visibility through GPS/telematics device integration.
- Deployment of adequate fleet, manpower, and maintenance support to ensure uninterrupted operations.
- Capability to manage day-to-day operations through the ABEPL defined digital platform (mobile app/laptop/computer systems) for receiving, responding to, and executing daily transportation indents.



The selected agencies will be expected to deliver services in a safe, efficient, and cost-effective manner while ensuring quality, minimizing transit losses, and contributing to the sustainability of the overall supply chain.

#### SUBMISSION OF APPLICATIONS:

Interested applicants, whether existing or new transporters, are required to submit complete information in the prescribed Application Format (Annexure-1). Applications may be submitted either via email or by physically submitting a hard copy, as detailed below:
